A quorum was established. Presiding Commissioner Phillips entertained a motion to approve all items listed on the consent agenda, which included approval of Christian County Commission's regular session agenda for today, July 22, 2019 as published, as well as approval of Certified Court Order 07-22-2019-01 (representing the July 2019 CART fund). There are no minutes to address. Eastern Commissioner Robertson so moved. Western Commissioner Bilyeu seconded the motion.

The Commission met with representatives of the Sheriff's Office for a second quarter report. Sheriff Cole gave updates on the Operations Division, the Patrol Division, and the Christian County Jail.

Sheriff Cole noted that due to an unfunded Supreme Court Rule their work load has increased significantly, as they are now having to perform the work of booking, fingerprinting, and taking care of work that should be completed by the arresting agencies (such as the cities). Presiding Commissioner Phillips asked how the unfunded mandate by the Supreme Court ordering the Sheriff's Offices to conduct juvenile investigations has impacted his office. Sheriff Cole said that it has increased the workload of his investigators, and has caused his office to spend money on specialized training for juvenile investigations.

Presiding Commissioner Phillips entertained a motion to approve the quarterly report as presented by Sheriff Cole. Western Commissioner Bilyeu so moved. Eastern Commissioner Robertson seconded the motion.

The Commission met with presenter Sheriff Cole regarding the renewal of graphics for fleet vehicles. Sheriff Cole recommended renewal with Ozark Printing Company. 
