The Commission met with presenters from Paragon Architecture and DeWitt & Associates in regards to Justice Center renovations. Mr. Younglove reviewed the total project costs, and Mr. Sutton reviewed the construction contingency. Mr. Younglove then presented schematics for the Commission to review. Sheriff Cole indicated that he could allocate some funds (depending on the cost) to help enclose some walls for office

space. Mr. Younglove then presented a document outlining the Justice Center renovations, along with a project breakdown with revised changes totaling \$7,885.00. Mr. Younglove then presented a Project Cost Analysis sheet. Discussion was held in regards to the budget of the project. Mr. Younglove then reviewed the project timeline, noting that it would be approximately 8 weeks before renovations would begin, and two and a half months for completion of project. Western Commissioner Bilyeu moved to proceed with the plans for the renovation of the Justice Center. Eastern Commissioner Robertson seconded the motion.


